# What is Ofqual's role?

To ensure that:

regulated qualifications reliably indicate the knowledge, skills and understanding students have demonstrated

people have confidence in the qualifications we regulate

schools and colleges have information on the full range of qualifications we regulate

# Summer 2025 exams and assessments

More than **1.3 million** students received GCSE, AS and A Level results at 6,011 centres

More than **6.5 million** results issued – GCSE, AS and A Level

**522,000** certificates for VTQ performance table qualifications

# Grading

Standards in qualifications are maintained year-on-year

Grade boundaries change between years and between exam boards

No pre-determined quota of grades

Outcomes may vary a little

Understanding grading: toolkit for schools and colleges

# Special consideration

For illness, injury or event outside of control which affects ability to take assessment or affects performance

Student must have fully prepared for assessment and covered whole course

Broader issues impacting teaching and learning are not eligible

# Access to scripts

Reviews of marking of exam / moderation of non-exam assessment

Marked scripts can be requested from awarding organisations

Can also be requested to support teaching and learning

# Resilience arrangements

- Purpose – to be able to provide evidence of student performance should exams and assessments not go ahead
- Gather evidence in line with [Ofqual's guidance](#)
- Avoid over-assessment
- Vocational and technical qualifications may differ
- Internal contingency processes



# Access arrangements

Rise in approvals for arrangements, particularly 25% extra time

**Ofqual** considers an **effective system** one that supports students to get **appropriate arrangements** for their needs and is **manageable** for schools and colleges, and commands **public confidence**



- Timely requests

## Malpractice

- **5,025** penalties issued to students in 2025
- **44.3%** of these involved mobile phones or other communications device
- Penalties range from a **warning** to a **loss of marks** or **disqualification**

# On-screen assessment



Ofqual is consulting **until 5 March** on a proposed approach to regulating OSA in GCSEs, AS and A levels in England [On-screen assessment](#)



OSA could benefit some students, but fairness a priority



Aims to support responsible innovation



Paper-based exams will remain central

# Artificial intelligence

Students must not use AI to produce work they claim as their own

Be aware of risks for exam and non-exam assessments

JCQ guidance: centres must ensure authenticity, prevent misuse, and require acknowledgement of any AI use

AI must not be the sole marker of any component, including non-exam assessment

# Reform

Vocational & Technical Qualifications: New qualifications **V Levels** (L3), **Foundation Certificates** (L2), **Occupational Certificates** (L2)

Nationally-set content, consistent grading, phased roll-out from **2027**

GCSEs/A Levels: proposals such as update subject content, explore on-screen assessment, strengthen resilience

Maintain progression routes and standards
